	<ul> <li>Non-affiliates we share with can include financial service providers such as banks, lenders, payment merchants, loan servicers, and non-financial service providers such as retailers, law firms and marketing companies.</li> </ul>		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.		
	<ul> <li>Our joint marketing partners may include companies providing financial, non-financial, or legal services.</li> </ul>		

### Other important information

**California Residents:** Under California law, we will not share information we collect about you with nonaffiliated companies, unless the law allows. For example, we may share information with your consent, to service your accounts, or to provide benefits you are entitled to. We will limit sharing among our affiliates to the extent required by California law. CA residents have additional rights to restrict our sharing of your personal and financial information with our affiliates (companies we own or control) and outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products or services. **Vermont Residents:** Under Vermont law, we will not share information we collect about you with non-affiliated companies, unless the law allows.
